#### **The Common**

Our Common and Open Spaces Sub-committee is dedicated to securing the future of Clapham's most precious asset. It advises on its maintenance and improvement for sport and wildlife and on the preservation of its character. We seek to improve the management of events on the Common and to discourage those of an inappropriate scale or nature.

#### **Roads and Transport**

Our Roads and Transport Sub-committee reviews and, where necessary, challenges transport issues, taking into account the interests of people who live, work, walk, use public transport, cycle and drive in the area.
