## BIDding for Clapham

In August the blank frontage of 17-18 The Pavement, a site long derelict, became a major talking point for passers by. It was transformed by a large scale 'cultural map' of the area, and panels describing the work of notable local people and other historical connections. The display was created by illustrator Jenni Starks with support from members of the Society's Local History Sub-committee. The double panel display is the conception of This is Clapham, the local Business Improvement District (BID) which came into existence in October 2014, and which has become a close ally of The Clapham Society in promoting townscape improvements, and interest in the area.

The stated prime purpose of the BID – a limited company run by a board of 12 local businesses, established under the BID Regulations 2004 – is to improve Clapham as a place to work, live, visit and do business. It has the ability to levy a modest rate on business premises within its designated area, which raises c. £220,000 per annum. From the outset the BID has demonstrated its determination to work with local groups, such as The Clapham Society, and has set up a number of theme groups to promote local initiatives, some of which aim to plug gaps in existing services, such as street cleaning. Others bring a welcome focus on creating a better local environment, and can attract extra funding from Lambeth Council, and other statutory bodies.

The BID's priorities in its first two years have, understandably, been to improve the management of the night time economy, to control anti-social behaviour and petty crime by introducing street wardens, and a radio link-up to local businesses, supporting the work of the HUB on Friday and Saturday nights,

George Hibbert MP was a leading parliamentary proslavery advocate, a Chairman of the Society of West India Merchants, Agent for Jamaica and an extensive plantation and slave-owner. He lived in a large house with a renowned garden on Clapham Common North Side.

and introducing weekend street cleaning services. It has also promoted a range of Business to Business services and events.

A number of initiatives that concern Clapham's streetscape deserve special mention here. In the main these take forward ideas generated during the Common Ground Green Infrastructure Audit undertaken last year.

Proposals have been drawn up or submitted to undertake a range of works on the green space behind Clapham Common tube station, sometimes referred to as the Grassy Knoll. The scheme involves some landscaping, new seating, and installation of programmable lighting in certain large trees here and down the High Street. Pressure remains to include the removal of some of the street clutter around this key meeting point as part of the scheme.

It was a major disappointment to the Society that the regeneration scheme undertaken in 2013/14 never fully implemented the proposed planting scheme. The BID is currently working on a proposal to undertake a planting programme that would deliver the original planting vision for Old Town, tied in with a proper maintenance plan.

The BID is working with Lambeth and TfL on a strategy to enhance the High Street. This initiative is led by Lambeth, with design work by TfL. A number of potential areas have been identified where townscape improvements could be achieved within the highway, and the intention is to select three areas initially for priority treatment. Consultation on sketch ideas is planned for early October.

High on the list of potential candidates for improvement are areas at the northern end of the High Street, around Voltaire Road and Clapham North tube station, and improving the pedestrian experience between the underground and overground transport services in this area. Other areas include the top end of Clapham Park Road where it meets the High Street, the potential to introduce more trees along the High Street, and the junctions at Venn Street and at Clapham Manor Street.

Other BID proposals under consideration include the installation and maintenance of hanging baskets in the fringe shopping areas, and installation of raised planting beds in certain areas.

## Belgian Refugees

We have recently been sent some fascinating information about a hostel for Belgian Refugees at 83 Clapham Common West Side. Looking through his grandmother's letters and documents, Clapham Society member Sidney Emery found some papers which belonged to her sister, who was lady-in-waiting to the Duchess of Vendome (sister of Albert I of Belgium).

There is a letter from the Treasurer of the Hospitality Committee, dated 28th October 1914, inviting the Duchess to open the Hostel for Belgian Refugees at 83 West Side, formerly Carlyle College for Girls, at 3 pm on Saturday 31st October 1914. It's not clear if she did attend (maybe the short notice was a problem?) because a second letter, dated 31st December 1914, reads 'Reverting to your promise to visit our Hostel, we should feel honoured if you would be so gracious as to favour us with your presence on Saturday the 30th January at 3 pm'.

Another document refers to the formation of the '**Hospitality Committee** of local residents for assisting in dealing with the **immediate and pressing necessity** that exists for accommodation of **Refugees from Belgium**.' It goes on to mention the generosity of the owner who has placed at their disposal the mansion 'which is capable of accommodating some 50 guests'. The names of members of the Committee, who are all residents of West Side and the streets immediately adjoining, are listed. This document states 'loans of beds, bedding, furniture and cooking utensils are urgently required'. These could be delivered to 83 West Side, where 'a duly authorised official will be in attendance daily from 3 p.m. to 9 p.m.', or they would be collected if a card was sent to the Secretary. 'Articles **loaned** should have the name and address of sender securely attached.' 'Gifts of money or in kind will also be most gratefully received by the Committee.'

On looking further in to the subject of Belgian Refugees I found it is estimated that between 225,000 and 265,00 refugees came to Britain during WWI and many to this area of south London. Wounded Belgian soldiers and refugees were also accommodated in a house in Cedars Road and one on Clapham Common North Side, and in Balham. The monthly magazine of St Andrew's Church in Battersea Rise had a regular column headed Belgian Notes, giving news of the Hostel on West Side, and one of the refugees wrote an article for the magazine. Wandsworth Heritage Service has the programme of a Belgian Refugees' Garden Party in June 1915, opened by the Duchess of Vendome and recorded in some detail in the *Wandsworth Borough News*.

There is no record of when the hostel closed, but it was probably soon after the end of the war in 1918, when up to 90% of refugees are said to have returned home almost immediately.

## Planning News

Details of representations made on planning applications since May are set out below.

**Clapham Common.** A recent application by the Council to use the Event Site for three events in July and August was submitted too late for a decision to be taken until after the events had taken place, making a mockery of the planning system. The application was subsequently withdrawn.

**Southside Court, Clapham Common South Side.** An application to tarmac the grassed area next to this modest block of flats across from the Common, for use as a car park. The proposal would spoil the open view to and from the Common and it is too close to the busy main road for safe vehicle access. The application was refused.

**83 Clapham Common North Side.** Criticism of an application to convert this house into five flats including a basement extension and a large glass box above the roof ridge. The proposal is unduly exploitative and additionally involves the partial destruction of the front garden which contains remains of the former Georgian house on the site. The application was refused.

**The Spinney, Windmill Drive.** An application to demolish and re-build what was the old One O'clock Club building for continued use as a school nursery. We felt that the scale and design of the new building damaged the character of the Common and the Conservation Area, and despite the valuable service the nursery provides, it is not an appropriate use of the Common whose role is to provide recreation facilities accessible to all. Planning permission was granted.

**St John's Church, 386 Clapham Road.** This application is for the construction of a new residential block at the rear of this listed church and the subdivision of the church itself to provide more flats and a reduced area for worship and community use. Notwithstanding the need to give the church a sustainable future we considered the extent of the subdivision damaged the building's special architectural interest. Permission was refused.

**32 Crescent Grove.** This was an application to convert the existing end-of-terrace listed building, part of which was originally a coach house and then more recently used as bed-sits, into two houses. The building is in need of improvement but we considered the extent of the changes excessive, damaging the building's special historic and architectural interest. The application was approved with some amendments.

**22-22a Thornton Road.** This application involved the demolition of two semi-detached houses in large gardens and their replacement with a six-storey block of flats. We expressed reservations about the impact of the proposed development on the low-rise character of this suburban street as well as on the setting of the neighbouring listed Cubitt villa. The application was withdrawn.

**Lambeth College, Clapham Common South Side.** An application to extend the availability of the college facilities for community use to Sundays may affect the amenity of neighbouring residents. No decision has been issued yet.

**24 Lillieshall Road.** The application proposes wide-ranging alterations as well as a basement extension and the overall effect damages the simple character of this modest listed house. The application was refused.

## An Anniversary celebration

The Old Thorntonians Association (OTA) was re-formed ten years ago as an active group – currently numbering 91 – pupils and staff of the former Henry Thornton School, on Clapham Common South Side and Elms Road. To mark the anniversary, which will be combined with the regular annual reunion, members will meet at The Windmill on **Tuesday 8 November** for a formal lunch. The Guest of Honour will be Bryony Hill, widow of Jimmy Hill, OBE, the Association's first President, elected in 2006; his successor, distinguished lawyer Michael Caplan, QC (1964-71), will also be present.

## Clapham Chamber Concerts

Richard Bean's adaptation of the eighteenth-century commedia dell'arte style comedy *A Servant of Two Masters* retains the original storyline, but updates the action to 1960s Brighton – filled with colour, chaos and the discovery that pubs also do food.

## St Paul's Church: Organ Restoration Project

The organ at St Paul's was built in 1880 by Forster and Andrews of Hull. Apart from a few minor changes, the organ is almost untouched from its original form. This is rare and very few Forster and Andrews instruments survive in such a preserved state. As such, the organ is of significant heritage value, as well as being integral to every aspect of worship at St Paul's.

Despite regular maintenance, the condition of the organ has deteriorated over the course of time and it now requires a full restoration. Without immediate attention, the life of the organ is no more than five years. The project will cost £120,000.

A contractor has been appointed and the fundraising committee can apply for grants and charity funding, but not until the sum of £60,000 has been raised. Support is needed to raise this.
