# Some Thoughts on Brexit

The guest speakers at our January meeting were French journalist Eric Albert, correspondent for *Le Monde*, who has been based in London for 14 years and Etienne Duval, freelance Franco-Scottish journalist and former TV reporter whose education and career have been divided between France and Scotland. They explained that they wanted the evening to be a discussion, rather than a lecture and invited the audience to intervene and ask questions whenever they wished. This led to a lively evening with the audience participating enthusiastically in the wide-ranging discussion.

It was interesting and frankly rather disquieting to learn about the effect of Brexit on two long-term UK-resident French citizens, who know and love both countries. They said that they were immediately treated as foreigners, and felt unwelcome. One fact that many of us did not know is that UK-resident citizens of European countries (apart from Ireland, Malta and Cyprus) were not allowed to vote in the referendum. The speakers commented on the post-Brexit outpouring of patriotism, even xenophobia, particularly in the right-wing press; the sense of superiority; the attitude that the EU needs Britain more than Britain needs the EU, and the threat to leave the EU if our conditions were not accepted. To some extent these attitudes had existed before, but they were reinforced by the 'Leave' vote.

It became clear from the discussion that a big problem was that the UK has always had a different reason for being in the EU – the ability to extend markets, whereas France, Germany and other continental European countries have seen it as a union to maintain peace. The fact that the EU is in crisis was conceded, as well as the rise of right wing parties and the possibility, even if remote, that Marine Le Pen could come to power in France.

Another point which arose was that people in the UK are generally ill-informed about government and especially about the EU and how it works, whereas in most

Sally Kevill-Davies, ceramic specialist who worked at Sotheby's and was a member of the BBC TV Antiques Roadshow team of experts for nine years will trace the fascinating history of the plants, which were grown at the Chelsea Physic garden, and painted on Chelsea porcelain plates during the 1750s. Sally, who lives in Clapham and is a member of the Society has written and lectured widely on ceramics, and last year published *Sir Hans Sloane's Plants on Chelsea Porcelain.*

European countries politics, and in particular how the EU works, is taught in schools and the public are better informed. French MEPs tend to be wellknown people who have retired from national government: in the UK it is the reverse, MEPs are often at the start of their careers and not known.

The British also have a different view of history: as an island they feel protected and they have not suffered invasion and occupation in the same way as continental European countries.

Etienne highlighted the fact that Scotland was a close ally of France for 500 years, and has a distinct attitude towards the EU, feeling as a small country it is advantageous to be aligned to the larger EU community than to England. He drew parallels between the referendum for Scottish independence and the EU referendum, though a chart he displayed showed that more Scottish voters opposed independence now than at the time of the referendum.

The question of oil revenues and trade deficits was raised, and it was noted that Ireland had made a recovery, and other small countries did well without oil revenues, which are erratic. The discussion could have continued for a very long time, as more and more issues were raised. Etienne suggested that an important outcome might be the effect on the British Constitution. The conclusion of the evening was that the Brexit story is far from over. This fascinating, disturbing and challenging debate raised our awareness of the many issues involved. Our thanks to Eric and Etienne for an evening which has given us plenty to think about.

# Clapham in the Past

We often receive emails both from members and others who just happen to find our website, sending us pictures and memories of Clapham in the past.

We recently received this splendid picture from David Lonsdale of the sports and leather goods shop run by his grandparents, Harold and Mabel Richards, at 55 Old Town. This is almost on the corner of Grafton Square, and is now one of three original shops which have been incorporated into the Sainsbury's Local. However, the decorated pilasters which divided the shops have been retained and are just as shown in this picture.

We have also received several letters from 81-year old Charles Murray, who lived off Landor Road and worked for Pinches Medallists, who occupied the former chapel of Clapham Grammar School in the High Street and the Surrey Conservatoire of Music at 1 St Luke's Avenue, now the home of Cactus TV. His two sisters also worked there. He remembered the Allard Motor Showrooms and Lyons teashop in the High Street, the Majestic Cinema now Inferno's, and Ross Optical works on North Side, now the offices of Experian. He also recalled the sweet factory (Batgers) on Clapham Common South Side and said that boys used to climb over the fence at the back to find the empty trays which had been put out at the end of the day, in which pieces of toffee were often left. This is the site (44 Clapham Common South Side) next to Lambeth College which is just about to be redeveloped.

One of Charles Morris's sisters contracted polio and attended the Open Air School on South Side. From our research on historic Clapham we know some of this information but it is particularly valuable to hear these first-hand memories.

# **Planning News**

Details of representations made on planning applications since last October are set out below.

**13** and **19 Lillieshall Road**. Both applications involve the installation of metal railings outside these listed buildings. We have consistently lobbied against railings (never an original characteristic of these modest cottages) and for the reinstatement of the original timber post and rail fences characteristic to Lillieshall Road, but planning permission was granted.

**93-99 North Street** and **North Street Mews**. Qualified support for a second application which provides for commercial space only in the mews, unlike the previous application for predominantly residential development. While the principle of commercial use is welcomed it will mean the loss of the existing workshops and hence many of the present activities in the mews. Some unwelcome extensions to the Victorian properties fronting North Street have been dropped, but on the other hand there are now no plans to refurbish them. The application has been withdrawn.

**Mayfield Close** and **rear of 83-87 Park Hill**. Objection to an application to build new houses in the Park Hill back gardens. The scheme damages the character of this part of the Park Hill/Northbourne Road conservation area. Access and parking will be in Mayfield Close, a sheltered housing scheme for elderly residents, and their amenity will also be affected. The application has been withdrawn.

**Eurohotels, Clapham Common South Side**. Objections to three applications involving advertising in front of the hotel and new entrance arrangements to Southside Court and Southview Court, adjacent blocks now in the hotel's ownership. All damage the character of their host buildings as well as that of the conservation area. All three applications were refused.

**2 Mackay Road**. This application involves a large roof extension and other alterations to the existing building which fail to respect the scale, consistency and character of Mackay Road, leading to overdevelopment and damage to neighbours' amenity. The application has been withdrawn.

**1 Newby Street**. Objection to an application involving a large and prominent roof extension which involves the loss of the house's traditional 'London' roof and damages the character of this little enclave of the Wandsworth Road conservation area. No decision has been issued yet.

**11 Lillieshall Road**. Of the 23 listed artisans' cottages in the street, no. 11 is one of the few yet to be modernised. We have liaised with the new owners on what promises to be a relatively modest scheme of refurbishment, retaining a reasonable amount of what is historically significant whilst bringing the property up to contemporary standards for living. No decision has been issued yet.

#### In Search of My Father

In 1960, my father, John Cushnan, left our Belfast home, his wife and seven young children and vanished. The next we heard about him was when we were told he had died in Clapham in 1982. I am investigating the 22 'missing' years.

From a collection of bits and pieces handed to me at his funeral, I know from 1974 to 1982 he lived in a bedsit at 6 Orlando Road, that he frequented the Rose & Crown pub on The Polygon, that he was an associate member of the Royal British Legion, Victoria Rise and that he may have attended services at St Mary's. He may have lived in Clapham for longer but I have no proof of that.

For official records like employment, he was John Cushnan. Amongst his friends, he chose to refer to himself as John Kelly from Derry. He was employed in the area by The Express Lift Company.
